

Minutes of the Annual General Meeting of Hambleton Parish Council Friday 5th MAY 2023, 7.15pm At Hambleton Village Hall

14/23 To carry out the Election of Chair and Declaration of Acceptance of Office

Councillor Jeff Bramley nominated himself for Chair, seconded by Councillor Jenny Bramley. Councillor Maria Ferris was nominated by Councillor Dunne, seconded by Councillor Rossiter and accepted the nomination. Voting was 2 for each candidate and the existing Chair cast a deciding vote for Councillor Bramley. **Resolved:** Councillor Bramley elected as Chairman and signs the Declaration of Acceptance of Office.
